### SUMMER AID REQUIREMENTS

1. Be an admitted, degree seeking SPU student.
2. Submit a 2018-2019 FAFSA application (if not submitted already).
  - Must be received by SPU with a complete file before summer aid can be awarded.
3. Submit this *UG Summer Aid Application* to Student Financial Services (SFS).
4. To receive **Federal Direct Loan funding**, must be enrolled in a **minimum of 6 SPU credits**.
5. **Pell Grant** eligible students must be enrolled for a **minimum of 1 credit**.
